What is the purpose of this update?

This document tells you how the MFL Mutual Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. MFL Mutual Fund Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund


The MFL Mutual Fund is a managed portfolio that invests predominantly in Australasian listed property, Australasian equities, and international listed property. It may also invest in cash and cash equivalents, fixed interest assets and companies, funds or trusts that invest in property and are intending to list. Some underlying investments are held directly and some are held via an underlying fund. Listed property includes trusts or companies that own or invest directly in commercial, office and industrial property. The fund's equity investments will predominantly be shares in listed trusts or companies with a substantial property component. These could include, for example, ports, airports, toll roads, utility networks and retirement villages.

The fund aims to achieve a return (after the fund charge and before tax) on average over rolling three year periods that exceeds the composite index.

What are the risks of investing?

Risk indicator for the MFL Mutual Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there may be other risks that are not captured by this rating.



Annual return graph

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from the fund).


Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of -\$335 (that is -3.35% of her initial \$10,000). Sarah also paid \$0 in other charges. This gives Sarah a total return after tax of -\$335 for the year.

What does the fund invest in?

Actual investment mix² This shows the types of assets that the fund invests in. **Target investment mix²** This shows the mix of assets that the fund generally intends to invest in.
